GUIDELINES FOR SELECTION



Competitor should complete and return nomination form to Surf Life Saving Illawarra by close of business on 15 October 2010.

- 1) Competitors must be a financial and proficient member of an affiliated club of the Illawarra Branch. Competitors must be proficient for the 2010-2011 season to be eligible to compete. **Information will be checked on SURFGUARD. If there are any discrepancies, the competitor may be excluded from the BRANCH TEAM. It is up to the competitor to check with their club that they have their correct proficient and education awards to be eligible to compete.**
- 2) Competitors should endeavour to compete at all selection trials/carnivals unless extenuating circumstances prevail. Contact **must** be made to the Branch Team Manager or Branch Team Coach in relation to their absence.

CARNIVALS THAT WILL ASSIST WITH SELECTION PROCESS BUT NOT LIMITED TO INCLUDE:

- # 23 October 2010 – North Cronulla (U/15 – Opens) (Rd 1 East Coast Surf Festival)
- # 30 October 2010 – Towradgi (Rd 1 Sydney Water Series)
- # 6 November 2010 – Shellharbour (Rd 2 Sydney Water Series)
- # Boat Crews – any round of the ASRL/South Coast Boat Series

To assist with the selection of the team, all athletes that nominate for selection in the team are asked to attend the following training sessions/race scenario/selection assistance dates (please bring surf craft on these dates);

Wednesday 20 October 4.30pm @ Wollongong Harbour

Friday 22 October 4.30pm @ Bulli Beach

Wednesday 27 October 4.30pm @ Bulli Beach

Wednesday 10 November 4.30pm @ Shark Bay (northern side of Bulli Beach)

These dates will assist the selectors in picking the best all round team to represent Illawarra at the championships. It will be helpful to see the new U12's & U13's moving onto bigger boards, U15's moving into the U17 ages & ski skills associated with ages U17 upwards, new competitors to the area etc.

Any other carnival results prior to selection of the team can also be used as a guide by Selectors. (eg last season's major championships). Selectors will have total discretion in the selection process.

- 3) 2010/11 NSW Inter-Branch Championships will be held at The Lakes Surf Club (Central Coast) on Saturday 11 December and Sunday 12 December 2010. All team members are expected to stay with the team in suitable accommodation and remain in the team environment for the weekend. Competitors will be expected to travel up on Friday 10 December 2010. Accommodation will be provided for Friday and Saturday night only. All team members are expected to stay until completion of events on Sunday afternoon.
- 4) A levy of **\$120.00** will be charged to each competitor selected. This levy will help off-set the costs for accommodation (2 nights), dinner (Saturday night), breakfast (2 mornings), team clothing and other incidentals.
- 5) Team will be selected by Thursday 11 November 2010 & details will be posted on the SLSI website soon after. Once team has been selected each team member will be contacted by SLSI & Team Management
- 6) First team training session will be @ Bulli Beach on Wednesday 17 November 2010 commencing at 5pm. Information sheets will also be given to each team member at the first training session.
